1. Introduction

The INCA financial statements, including the income and expenditure account and balance sheet, for the year ended 31 March 2019, are circulated to INCA members for approval at the AGM.

2. INCA Financial Statements

The accounts for 2018/19 show a surplus of £9,816 against a budgeted surplus of £17,302. The accounts for the previous year showed a deficit of £5,184.

Key points to note:

- Income from Subscriptions decreased following a net loss of 14 members during the financial year.
- The INCA Awards posted a surplus of £3,272 compared to a budgeted surplus of £5,113.
- Meetings include four Board meetings, one members' meeting, one AGM, and Committee expenses.
- Subscriptions include EAE, Build UK and the British Energy Efficiency Federation (BEEF).
- The PR and Marketing budget has not been used this year, as no amendments have been made to the website, nor marketing undertaken.
- Executive Chairman includes the role fulfilled by Mitch Gee between September 2017 and the end of the financial year.
- No technical projects have been undertaken by INCA in this financial year, hence this figure stands at 0.
